Awe-tumn Comes to Big Cottonwood Canyon

Short Term Rental Survey



When Brighton became a town in 2020, the highest priority was to maintain a strong community. Regulation of short-term rentals (STRs) was one of the first issues considered. Here's a link to the current ordinance that was approved by the Town Council in 2021: Brighton's Short Term Rental Ordinance. As we look forward, the Short-Term Rental Committee has been considering ideas that other communities use to maintain a mix of full-time and seasonal family cabins. Current Short Term Rental Data. Solitude is already zoned to permit all STRs.

Most other areas are not permitted to have STRs due to lack of sewer access.

The STR Committee has designed a survey to solicit input from Town members. Please take a minute to respond! There are five proposals in this survey that suggest STR caps. Happy Trails Ahead

Cardiff Bridge and Trail. Salt Lake County and the US Forest Service are getting ready to finish the Donut Falls access trail. The Donut Falls Trailhead in Cardiff is the most heavily visited trail in the Wasatch. Forest Service officials wanted to create a trail that will keep foot traffic off the sensitive riparian meadow, and encourage hikers to stay off the narrow Cardiff roadway. Many families come to photograph weddings, engagements, Christmas cards, and family reunions. The new trail will make it possible for those events to take place on the trail/bridge and avoid trampling the meadow. The Town of Brighton recently provided funds to help the Forest Service hire a Ranger to enforce the rule against trespassing (and glitter) in the meadow. A wider dirt trail to the



west of the bridge and moraine is almost finished so that wheelchairs and strollers can get to the trailhead. Although the project has been delayed due to supply-chain difficulties, the target is still to finish in October.



Silver Lake Boardwalk. The Silver Lake Boardwalk reconstruction is finally underway. During this month the west side of the trail will be entirely removed and replaced with weather-treated lumber. Hikers can still use the other side of the boardwalk. Next year, the Forest Service will replace the other side of the boardwalk. This is the only ADA compliant trail currently available in the Wasatch National Forest and is a favorite destination for visitors of all ages and abilities. Forest Service officials say over 30,000 people visit this location on a busy summer weekend.

Geological Signs. Check out the

three geologic signs have been updated and installed this summer! This project was funded by BCCA, CWC, and the Utah Geological Association (UGA). Collaborators include US Forest Service, University of Utah College of Mines and Earth Sciences, Brigham Young University Department of Geological Sciences, and the Utah Valley University Department of Earth Sciences. Each institution helped provide updated geological interpretations based on the latest research for each location. Volunteers from the UGA provided the muscle for the installation this month.

Town of Brighton General Plan

After a year of collaboration and 5 Public Open Houses, the Brighton General Plan is finally ready to be presented to the Planning Commission. Public comment is encouraged. The Plan is divided into five parts: Land Use, Transportation, Housing, Natural Resources/Recreation/Tourism, and Resilience /Infrastructure. UDOT Comment Period Open Through October 17

UDOT has identified the Gondola as the preferred alternative to improve transportation in Little Cottonwood Canyon. They say this alternative provides the highest travel reliability and the least impact to the watershed. A base station with 2,500 parking spaces near the LaCaille Restaurant property is planned. Snow Sheds will be constructed at major slide paths to protect motorists from avalanches. The projected cost is \$550 million which includes the cost of tolling infrastructure, snow sheds, and parking structure.

The plan includes tolling for both Cottonwood Canyons. The tolling gantry for

Big Cottonwood would be located near Spruces Campground, and is only projected to be used on busy weekends, holidays or powder days. Toll amounts will range from \$25-\$30. If you can make a comment, click HERE

Road Construction Continues

The Rocky Mountain Power Wildfire Mitigation project will continue through October. The goal is to bury conduit in the road down to the Stairs Station. Next year the project will begin near Pinetree and move up toward Solitude. Resident Passes



Last year, Resident Passes with no expiration dates were distributed to all Town property owners by the Brighton Emergency Teams. These passes are **ONLY** to be used on days when the parking lots at the resorts are **FULL**.

The Resident Pass shows UPD that you have your own parking at your residence. UPD notes that if the highway is closed for any other reason (ex: accident or avalanche), a Resident Pass will not even allow the President of the United States to have access. 


