The Tri-Canyon Trails Master Plan is the first-ever trail plan for Little Cottonwood, Big Cottonwood, and Mill Creek Canyons. Salt Lake County and the Forest Service will identify opportunities to protect watershed and ecosystem health while providing diverse recreation opportunities.

BCC-MAP SURVEY BEGINS IN JANUARY

The Big Cottonwood Mobility Action Plan (BCC-MAP) will reach out to the public in January to ask questions about how transportation could be improved in Big Cottonwood Canyon. The study will:

- Evaluate the existing network, identify gaps, and consider past plans.
- Develop mobility hubs that feature amenities, reliability, and year-round service.
- · Protect critical resources.
- · Define a prioritized list of near-mid-and long-term recommendations



Watch for this exciting outreach in January. The project is being conducted by the Central Wasatch Commission.

Snow Berms. Snowplow drivers are asking for our help in busting the berms in driveways and entry roads that are created by the big UDOT plows. Their mission is to clear the snow on busy days and the equipment unfortunately doesn't have the ability to groom around smaller areas. They would also appreciate our efforts to disburse the berm to the landscape, and not back onto the road. It's all part of living creatively in the snow. No Roadside Parking at Guardsmans. Sometimes Guardsmans Pass Road becomes impassible because of cars parked on the roadside. For the remainder of the winter, there is no roadside parking allowed except up by the winter gate. Private parking is still allowed for Forest Glen residents on the road at the hairpin turn.

Parking at Solitude. Parking is free at Solitude if you have 4 or more people in your car. Be sure to ask the parking attendant for a coupon to prove you have 4 people before checking in at the parking kiosk. Lifts open at 8 am on weekends until mid-March. Employees of both Brighton and Solitude are parking at Butler Elementary and Hillside Plaza to make extra room for customers.

Road Closure Notices for Residents. We are working on getting efficient messaging out to residents who are full and/or almost full time in the canyon when there are temporary road closures due to slide offs or other problems. These are not town emergencies but can cause major difficulties for residents if they do not know what is happening. I would like to compile a list of people that would like to receive a text message if there is a major delay or closure.

From the diary of Leoline Brown ~ Brighton, Utah 1909

2 good lemons 1 can grated pineapple 2 cups sugar ½ of a 10 lb. pail of snow Grate rind and juice lemons
Drain juice lightly
Mix all ingredients together
When ready to serve, mix fruit well
with snow. If lumpy, chop it up.
