**MINUTES** from BCCA meeting on August 12, 2019, were approved as submitted.

## REPORTS

**UPD** – Lee Arnold reported that shuttles for the Revel Marathon will start at 6 am. Intermittent traffic will take place in the uphill lane. The race should be clear of the canyon by 11 am. Traffic on Labor Day reported 800 cars per hour were in the canyon between the hours of 10 am and 12 pm. Over the three-day holiday weekend, 41,000 cars reported driving up the canyon. The DA's office is looking at the possible increase in the dollar amount for parking fines in the canyon. Lee will look into the possibility of an ambassador program to control parking and traffic at the summit of Guardsmans Pass.

## BUSINESS

**Special Order – CCTAP (Cottonwood Canyons Transportation Action Plan)**, The study team, gave the BCCA an overview of the Transportation Action Plan updates. The study is in the Needs Assessment Phase, and comments are being collected on the web site. The summary included traffic reports comparing seasons in the canyon reporting Labor Day as the most massive traffic day of the year. Big Cottonwood shows evidence of more traffic in the summer than in the winter. The plan includes Active Transportation study, Transit Alternatives Evaluation, and tolling strategy. Barbara also acknowledged Ralph Becker and Blake Perez and thanked them for their work on the CWC.

**Conditional Use Permit** – Jim Nakamura reported 6270 River End Road Permit is on hold for proof of year-round water. Silver Fork Greg Larson, 6704 Hulse Ave, SF, remodel was approved with the request that the address of the property is appropriately displayed. The property was inspected for water, sewer, and parking regulations. BCCA recommended approval with the request to post the list of ordinances.

**Hawk-** Barbara informed the group on updates on the Hawk and a discussion about the pros and cons of the Hawk were discussed. Barbara will report back on any further updates to the project.
