## **MINUTES**

The minutes of April 10, 2023 were approved as submitted.

### **FINANCIALS**

Checking \$444.68 Savings \$30,890.89

**UPD-Cheryl Lenzer** 

For the month of March we had 371 calls come in for the canyon. We had numerous traffic accidents and vehicle assists. There were seven reports generated for vehicle tows, mostly due to vehicles parked in the roadways and clogging up lanes of travel. There was one Search and Rescue and several frauds and thefts. Officers worked a total of 52 hours of traffic enforcement shifts and wrote 238 Parking Notices.

Please put June 10<sup>th</sup> on your calendar for the Drop 13 race. More details to come next month but it should be the same traffic control for the canyon as it has been in the past.

We appreciate all of your help and patience with the canyon closures we have had and during the recent snow storms.

## **UPD-AR Bennett**

Sgt. Bennett reported that the Mental Health Unit began in 2019, and included a mental health expert from Salt Lake County Mental Health Department plus one other police officer. The Unit receives about 5,000 calls per year. They work with 5 metros including Draper, Cottonwood Heights, South Salt Lake, Murray, and Midvale. Millcreek has approved funding for a fulltime additional employee for the Unit. Brighton contributes funding also, as part of the shared services from UPD. When a call comes in, patrol will respond and stabilize the situation. If needed, the MMH Unit will be called. When they arrive, patrol officers are released back to patrol. The MMH Unit does some of the most expensive case management of any in the county. They strive to be proactive rather than reactive, and have cut constant caller rates by 80%. They work with hospitals and clinics to serve and care for people in need of mental health. It has been a successful start to a vital service.

**Town of Brighton Update.** Jenna reported that the Town Council will consider a possible increase in sales tax in the case that Recreational Area UPD funding is no longer available from the County. She explained the UPD funding situation and the burden it has put on Brighton, Millcreek, Holliday, and all the Metro Townships. She is hopeful that solutions will be set forth in the next couple of months.

**Community Updates.** Each community gave a brief snow update.

**Brighton**-Don Despain and Kathy Anderson reported deep and dangerous snow conditions, with 3 structure failures, including the old fire station. This may require changes in FCOZ engineering requirements. Paul Nell has done a heroic job with the snowplowing. Don suggested that BCCA sponsor a thank-you luncheon for the UDOT Crew at the Dask Greek Restaurant.

**Forest Glen**-AnnMarie Hannon reported possible road closures in FG B/C. Structures appear to be intact. **Lady of the Lakes/Evergreen**-Jim Keener reported that he is concerned about powerlines that are so close to the ground that skiers may run into them. The area is just off the Sol-Bright Trail, which luckily hasn't been open very often this season. John Knoblock will talk with Amber Broadaway about the possibility of posting some "Area Closed" signs if the Sol-Bright is opened again.

**Solitude**-Bryan Luftglass reported that Adam Peters is doing a fantastic job with the snow removal both on roofs and on the ground. No structure failures.

Giles Flat-Peg Kramer reported that the mailboxes are out of commission, and the Post Office is no longer able to deliver mail there. All mail is being held for pick-up at the Cottonwood Heights Post Office. If there are questions, please contact our mail carrier, Leisa Gutierrez (801-824-0580) Silver Fork-Jenna Malone reported one garage failure. Kara John said a County engineer had come up to take a look, but didn't find any structures that needed obvious help. He suggested that people call an independent engineer to help with repairs if they suspect trouble in the coming months. It's very difficult to remedy streams and bridges right now with the amount of snow. They should be evaluated as the snow melts this spring. The most important thing is to shovel roofs to take the weight off.

**Pinetree**-Paul Kuhn reported persistent power outages in Pinetree. There are no structure failures. He also gave the address where people can get free sandbags: 604 W. 6960 South in Midvale **Maxfields**-Brooke Derr reported that homes in the area are in good shape structurally, but they are concerned about flooding. In 1983, the little bridge at Storm Mountain was taken out.

# **Resort Report**

Kim Doyle reported that Brighton is planning several summer events, including Sunday Brunch. The Milly ski lift will be open until Memorial Day. It's been a challenging and historic year. The meeting was adjourned at 8:30 pm.
